A Round Robin (RR) is a type of Permanent Court Time (PCT). PCT contracts are for day and time not a specific court or instructor. **A \$50.00 NON-REFUNDABLE PAYMENT** applicable against PCT charges must accompany each player's reservation, \$100 for a singles reservation. For a **non-lesson PCT**, the **per-court deposit must total at least \$200**. For a **PCT lesson court**, the deposit is **\$300 per member student**. NTC may cancel junior member's PCT lesson if the junior member is not enrolled in the group lesson program. I understand that PCT/RR reservation are a full season commitment for the same time each week during the PCT and RR season with the exception of Labor Day, Thanksgiving, Christmas, New Year's Day, Easter, Memorial Day and Christmas and New Year's Eves after 5 p.m.. PCT cannot be canceled, but if group is unable to use the court, and Club is notified, an attempt will be made to sell the time. If time is sold, credits will be applied. In contracting for a permanent court time lesson, I agree to the NTC Instruction Rate Schedule, incorporated into this contract by reference.

* Jr. Excellence Membership is required to participate in our Junior Excellence Drill & Play sessions. Participation in the Jr. Excellence Drill & Play includes iCompete Membership & Half Price Walk-ons.

As a condition of the membership, the Applicant/Guardian agrees to pay the initiation fee (if applicable) and membership fees stated above, in addition to tennis/pickleball court time and any other club purchases.

The Applicant/Guardian agrees to provide a Visa, MasterCard, Discover or AMEX in order to participate in the Electronic Funds Transfer (EFT) payment program. This program's payments will automatically be processed monthly.

Membership rates are effective June 1, 2019 and are subject to change.

Monthly Payment Options allow freezing months, with advance written notice, by paying half the monthly amount. For example Snow Birds might want to freeze their membership from December through March. (If playing non-USTA teams or receiving Fall lesson member prices, August is not be eligible to freeze.)

Month to Month Membership requires 30 day written notice to cancel monthly billing. All balances due need to be paid in full at time of cancellation. This membership is not available to those on non-USTA teams, currently with one or more PCTs or in Round Robin Leagues.

An Initiation fee is not required for renewals. Initiation fee is waived for 2018-19 members who renew by 9/1/19.

All memberships that are not renewed at the next season's Preseason discounted rate will automatically renew to monthly billing until the Applicant or Club cancels the membership. The Applicant/Guardian may cancel a renewed membership any time after the current season has ended by submitting written notice 30 days prior to cancellation and by remitting all amounts owed to the club. Once written notice is received, termination will take effect on the last day of the following month.

NTC reserves the right to cancel a membership, or any reason. In the event of NTC cancellation, pro-rated membership fee will be returned to the member, less any amount due NTC. PCT fees and team drill fees are not refundable if a seasonal membership is cancelled.
